Air Products and Chemicals, Inc. Long-Term Incentive Plan (the "Plan")

The Company's consolidated financial statements included \$1,670 million in total assets (10%) and \$140 million in total sales (less than 2%) associated with Indura S.A. as of and for the year ended 30 September 2012. Our audit of internal control over financial reporting of Air Products and Chemicals, Inc. also excluded an evaluation of the internal control over financial reporting of Indura S.A.
