EXHIBIT A

Auto Company also sponsors a qualified retirement plan for the benefit of its employees, which plan is named the State Farm Insurance Companies Employee Retirement

As part of its corporate structure, Auto Company has established an Investment Department. Except for assets managed by SFIMC, the Investment Department is directly or indirectly responsible for managing or overseeing the management of the investment and reinvestment of assets owned by each person that has joined in filing this Schedule 13G. Moreover, except for assets managed by SFIMC, the Investment Department is responsible for voting proxies or overseeing the voting of proxies related to issuers the shares of which are held by one or more entities that have joined in the filing of this report. Another division of Auto Company is responsible for managing or overseeing the management of assets for which SFIMC is responsible. Another division of Auto Company also is responsible for voting proxies or overseeing the voting of proxies related to issuers the shares of which SFIMC has investment discretion. Each insurance company included in this report has established an Investment Committee that oversees the activities of the Investment Department in managing the firm's assets. The Trustees of the Qualified Plans perform a similar role in overseeing the investment of each plan's assets.

Pursuant to Rule 13d-4 each person listed in the table below expressly disclaims "beneficial ownership" as to all shares as to which such person has no right to receive the proceeds of sale of the security and disclaims that it is part of a "group".
